The manager instructs you to copy all files from the employee's computer and transfer them to the department. However, the manager provides no written approval from Human Resources (HR), senior management, or the organization's information security office. Company policy states that employee files may only be accessed under exceptional circumstances with proper authorization and documentation. You know that the employee's computer may contain confidential financial records, personal emails, private documents, and medical information. Refusing the manager's request could delay the audit, while complying without authorization may violate company policy, employee privacy, and professional ethical standards. |   | b) | <p>You are a Software Engineer working for a company developing an AI-based railway signaling and train-routing system. The software automatically controls railway switches, assigns train routes, and prevents collisions by processing real-time sensor data. During the final system testing phase, you discover a programming defect. Under rare conditions, the AI algorithm may incorrectly route a train onto an occupied track. Although the probability of failure is estimated to be very low, the consequence could include train collisions, passenger injuries, loss of life, and major property damage. When you report the issue to your project supervisor, the supervisor states that fixing the bug would delay delivery by several weeks and could result in financial penalties and loss of the government contract. The supervisor instructs you not to disclose the defect, arguing that "the chance of failure is almost zero" and that the issue can be corrected in a future software update.
